- The disinfectant product we use is approved by Health Canada and defined by the EPA as “practically non-toxic and not an irritant.”
- It contains no ozone-harming volatile organic compounds (VOCs), and is mild on skin, hard surfaces and fabrics.
- For food-service facilities, it is rated “no rinse required on food contact surfaces” category D2 by NSF International. This means it is approved for use in commercial or residential kitchens to control bacteria, viruses and mold without the need to wash/rinse the area with water.

Once the product application has dried, the label assures 100% disinfection of all bacteria and viruses on hard, non-porous surfaces.
